## IAM / AIR CANADA PENSION COMMITTEE RETIREE REPRESENTATIVE REPORT

Dear Brothers and Sisters:

My name is Ed Wainwright and I am the Retirees Representative on the IAM / Air Canada Pension Committee. I have been an active member of the IAM for more than thirty (30) years and have been a member of the Pension Committee for IAM employees at Canadian Airlines and then Air Canada since 1980. I have been retired from Air Canada since 2009 and have been enjoying my retirement considerably.

There is a statutory requirement for a Retiree Representative on federally regulated pension plans like ours. Article 7.1 of the *Pension Benefits Standards Act (PBSA)* stipulates that pension committees for plans with more than 50 retired members must "... **include a representative of the retired members.**"

There is also a contractual requirement for a Retiree Representative. Article 15.2 of the IAM / Air Canada Pension text explains the composition of the Pension Committee:

15.2 The members of the Committee established pursuant to Section 15.1 shall be:

- a) three (3) management employees appointed by the Company; and
- b) three (3) representatives of the Members of the Plan and **one representative of the Former Members in receipt of a pension appointed by the Association.**

(Please note that the Retiree representative constitutes an IAM majority on this Committee)

As per Transportation District 140 Bylaws and Policies, I have been appointed, for a period of 4 years, commencing in January 2014, to act as your representative on the pension Committee. The roles and responsibilities of this appointment include:

- a. To act as the District Representative reporting to the General Chair assigned the responsibility for the specific Employer Pension Committee and the National President Directing General Chairperson (PDGC) as necessary.
- b. To attend and participate in all Air Canada Pension Committee meetings.
- c. To provide any reports or retiree support activities as requested by either Transportation District 140 or the Employer Pension Committee Chairman.

As a member of the Committee, I act on behalf of the members to monitor the administration, review the financial performance, provide members with information and assist members having difficulty with any aspect of their pensions.

I will do my best to get back to members in a timely fashion and provide information and assistance, as required.
